The Wapentake of Ewcross does not occur in Kirkby's Inquest or in the Feoda Militum. Page 278: Section on **Aid granted to Edward 1**, (June 1st 18th year ie.1290) records the following

Thorneton.

De Rosea de Moubray pro quinque car. terrae in Thorneton, unde xiiij car.,etc,xiiijs iiijd ob De Ingramo de Gynes pro duabus car. terrae in eadem, ude, ut supra vs ixd De Gregorio de Thorneton pro una car. terrae in eadem, unde, ut supra ijs xd

Parliament granted an aid of 40 shillings from each knight's fee for the marriage of the king's eldest daughter. The aid was not collected until the 30th year of Edward 1 (1302)

Roesia was the widow of Roger de Mowbray and sister to Gilbert Earl of Clare. (Dugd. Bar. i, 126) Christiana quoe fuit uxor Ingelrami de Gynes was living in the 19th year Edward II (1326) –**check** (Abbrev.Rot. Orig. 293)

On May 22nd 1322 Archbishop Melton ordered 20 marks to be paid to Gregory de Thornton knight "in part payment of 100 marks due to him for our service to be rendered in Scotland to the king, which he is to do." Fasti. Ebor. I, 427.

A further sum of £60 was paid to him on July 4th 1322 (ibid 427n)

The Nomina Villarum describes the Lords of the Manor throughout England from 1316 to 1559. This particular transcript was made in the early part of the reign of Elizabeth. Note this record contains several errors and omissions

Roesia de Mowbray for 5 carucates of land in Thornton, in respect whereof 14 carucates etc 14 s.4d on this account
